Why does Jacques Derrida speak of the trace in terms of ash and cinder (*cendre*)? "I would prefer *ashes*," Derrida has said, "as the better paradigm for what I call the trace – something that erases itself totally, radically, while presenting itself."<sup>1</sup> In *Cinders*, Derrida writes that cinders are "the best paradigm for the trace," better than "the trail," "the fraying," "the furrow," or the many other names he has given to the trace structure since his first publications from the 1960s. But he has also written that cinder is only one name among others for "these remains without remainder": "Trace or cinder. These names are as good as any other."<sup>2</sup> Cinder is at once the best name for the absence of a truly proper name for that which holds all beings and entities in presence, and by the same token just another name that cannot begin to assess its distance or proximity to the final proper name (or names) of the truth of Being, whose very existence remains undecidable. Cinder is the best name, in Derrida's estimation, among all the names that have thus far presented themselves, but it is merely another name when considered in relation to the still withheld truth of Being. The naming of a cinder thus resists presenting itself as the privileged name or metaphor for that which brings things to presence and sustains them there. It is at the same time a name that resists the temptation to make the play of metaphor itself synonymous with the truth of Being. Cinders are neither proper nor metaphorical names; cinders name another relation, not to the truth as such, but to its possibility.

Why are there cinders rather than nothing? Why does language bear something within itself that somehow signals a language beyond language, that signals *that* there are conditions for the

possibility of a language without saying *what* those conditions are? Why does language bear within itself the traces of something that cannot be exhausted by pragmatics and historicity, something from which the *pragmata* of history themselves arise? "Cinders there are" (*Il y a là cendre*), "there are cinders there," "there" where the marks of a divisible materiality within language, within its syntactic and linguistic stuff, trace the infinitesimal cinder quarks that remain from whatever it is that makes it possible and necessary that a language comes into being. Cinders are the quarks of language, neither proper names nor metaphors, the traces of neither ontotheology nor of the generalization of metaphor, naming neither truth nor its impossibility, but all the while keeping a space open into which the truth, or its impossibility, might come, a space, as Derrida calls it, for the in-vention, the *in-venire*, the in-coming of the other.<sup>3</sup>

Cinders are all that remain of the path that might someday lead back (or forward) to the origin of language, the path that opens the possibilities of the metaphoric and the literal without being reducible to either of them. Though it is one name among others for this path, trace, or trait that separates and joins the figurality of poetic or metaphoric naming to the philosophic thinking of the literal, a cinder is nevertheless a very specific name whose associations with heat, fire, and

conflagration figure prominently in Derrida's usage. In the warmth of a cinder one can feel the effects of the fire even if the fire itself remains inaccessible, outside cognition though not without leaving a trace. Thinking and poetic naming lead us only so far on a cinder path, for cinders cool and fall to ash and the path leads no further. Does something within language really burn? Does language bear within itself the remains of a burning? *Cinders* is about the fire that is still burning at the origin of language, the not yet literal but more than figurative fire that can be felt in the cinders of a language.

The fire has always already consumed access to the origin of language and thus to the truth of being. But by leaving cinder remains, it allows the relation between the coming of language and the truth of being to persist, to smolder within the ashes. Cinders name both the extreme fragility and the uncanny tenacity of this relation.

A cinder is a very fragile entity that falls to dust, that crumbles and disperses. But cinders also name the resilience and the intractability of what is most delicate and most vulnerable. *Il y a là cendre* literally means "it has ashes there, there." By rendering the idiomatic *il y a* by "there is," we install the intransitive verb "to be" where, properly speaking, it does not belong, for in the French idiom what is in question is not the "being" of the entity but its "there-ness." As in the German *Es gibt* (literally, "it gives"; idiomatically, "there is"), *il y a* makes no determination concerning the ontology of the essent. Each time we read the refrain *il y a là cendre*, "cinders there are," we should remember that the delicate vulnerability of a cinder leaves open the question of its being or non-being. We should hear within "cinders there are" something like "it has cinders," or "it gives cinders," or "cinders persist," where what "it" may be and what "persistence" might entail are among the questions the phrase poses without implying that it already has the answers.

Martin Heidegger also emphasizes the delicate nature of the rela-

tion between language and truth; between figure and idea; between the thick condensations of *Dichten*, or poetic naming, and the quasi-conceptual determinations of thinking, or *Denken*, which are, he writes, "held apart by a delicate yet luminous difference" (*zarte aber helle Differenz*).<sup>4</sup> Though this delicately glowing "rift" (*Riss*) holds metaphor and the literal apart, this holding is itself a relation (*Bezug*) that keeps them from being "separated in a relationless void" (*ins Bezuglose abgeschieden*). In *Cinders* this luminous glow emanates from within the ashes, and now it is less a question of seeing the light than of feeling the heat. It is the event in which this luminous rift "incises" itself into *Dichten* and *Denken* and thus draws them, engraves them, sets them into "the design [*Aufriss*] of their neighboring nature" that Heidegger names the *Ereignis*, which for Heidegger always entails a double movement in which language is incised by the withdrawal of the unnameable otherness of its origin and is thereby set into its own proper nature. As Derrida remarks in his reading of this passage of Heidegger's "The Nature of Language," the incisive movement of *Ereignis* "is structurally in withdrawal": "Its inscription [. . .] occurs only by effacing itself."<sup>5</sup> In *Cinders* the appropriative-disappropriative structure of *Ereignis* is enacted through the withdrawal of the fire that continues to burn in a cinder. The coming of language as a means of thought and expression is always also the withdrawal within language of the trace, the trait, the *re-trait* of its concealed origin. Heidegger writes elsewhere that "language is the most delicate [*zarteste*] and thus the most vulnerable [*anfälligste*] vibration holding everything within the suspended

structure of the *Ereignis*" (*alles verhaltende Schwingung im schwebenden Bau des Ereignisses*).<sup>6</sup> It is the heat within the resonance of this oscillation that Derrida names *là cendre*. Cinder names the tender susceptibility of that vibration, that ringing, that burning within language. To hear, to speak, to write, is to feel the heat, to feel the retreat of the fire as a cinder falls, yet again, to ash.

At what temperature do words burst into flame? Is language itself what remains of a burning? Is language the effect of an inner vibration, an effect of light and heat upon certain kinds of matter? *Glas* begins and ends with an allusion to Hegel's notion of *Klang*, the "ringing" at the origin of language that Hegel discerns in the legend of the "colossal sounding statue" (*Klangstatue*) of the Memnons in ancient Thebes, which emitted a sound when struck by sunlight at sunrise.<sup>7</sup> It is on the border between speech and *Klang* that the path to the origin of language becomes impassable; and it is there that a cinder burns. Sound is first the escape of heat; so also for Derrida is language. *Il y a là cendre* initially presents itself to Derrida as a ringing tonality before it becomes a meaningful utterance. The ideal materiality of its broken music precedes the unfolding of its poetic and philosophic resonance. *Klang*, writes Hegel, is "the ideality of materiality" that characterizes "the transition of material spatiality into material temporality."<sup>8</sup> For Hegel *Klang* names the initial ringing at the beginning of time, the sound of the first burning, the sound of the fire as it rushes from absolute space into the relative space of universal creation. "The bell," writes Heidegger, thinking of Hölderlin, but perhaps also of Hegel, "— rather its *Klang* — is the song of poets. It calls into the turning of time."<sup>9</sup> Poets enable us to hear the tones and echoes which this *Klang* has traced into a language, whereas thinkers speak of the causes and the consequences of these traces. As Derrida's *ars metaphysica*, *Cinders* leads us into those spaces within the French language where

one can still hear something burning, still hear the ringing in language of a burning more ancient than time and space.

Cinders bear the traces of this most ancient materiality within the empirical, extended materiality of measurable space and time. The smoldering ashes of another materiality ring from within the tonalities of a material language; within the idioms of a language burn the remains of something other than a singular idiom, the cinders of a still lost and unreadable genealogy.

"Spirit is flame," writes Heidegger, "It glows and shines."<sup>10</sup> Heidegger's essay "Language in the Poem: A Discussion of Georg Trakl's Poetic Work" is treated at some length in Derrida's *Of Spirit: Heidegger and the Question*, where Derrida focuses on the way Heidegger's idioms name the burning of the earliest beginning within the German language.<sup>11</sup> *Of Spirit* is very closely linked to the language and the problems raised in *Cinders*, for the latter text seeks within the French language the still burning traces of the most primordial beginning. In "Ghostly Twilight" (*Geistliche Dämmerung*) Trakl writes: "Forever rings [tönt] the sister's lunar voice / Through the ghostly night."<sup>12</sup> It

is through the ringing sound of this voice that the fire of the spirit gathers the soul of the poet. The coming of the phrase *il y a là cendre* likewise passes through this *geistliche Nacht*, this  
4 "ghostly night," where *geistliche* means, not the insufflating breath of *pneuma* or *spiritus*, but the still burning ringing of what Heidegger calls "the stiller, brighter earliness."<sup>13</sup>

Derrida's French in *Cinders* is scorched by the ghostly spirit that gathers and draws its idioms into relation with the secret that burns within the essence of a cinder. Georg Trakl's sister, Margarete, calls him into the "Evening Land," into the "Occident" which is the site of what the poet calls "one generation," "one kinship," "one flesh," "one gender," all of which translate "ein Geschlecht." Beyond the incestuous echoes that surround the enigma of Trakl's relationship with his sister, the ringing of the fire in language calls the poet to a more primordial unity. The "cinders love me," writes Derrida, "they change sex, they re-cinder themselves, they androgynocide themselves." The feminine voice of *La Cendre*, "she, the cinder," plays in *Cinders* a role not unlike that of Margarete Trakl. But, as Derrida repeatedly maintains, the gender of the cinder is highly unstable; thus, in his untranslatable French neologisms, cinders "*s'andrent*," which rhymes with *cendre*, and they "*s'androgynocident*," which evokes *cendre*, androgyny, and genocide. *Geist* gathers language into the cinders of "ein Geschlecht."

*An open region that holds the promise of a dwelling, and provides a dwelling, is what we call a "land." The passage into the stranger's land leads through ghostly twilight.*

Toward the end of *Cinders* Derrida alludes to Friedrich Nietzsche's notion of "eternal recurrence" and to his idea that "our entire world is the cinder of innumerable *living* beings." In

other words, even inanimate and inorganic matter is the cinder of what was once living. Nietzsche's idea that the universe is itself a cinder that burns and cools and then burns again anticipates Albert Einstein's notion of an expanding and perhaps contracting universe of finite mass and energy. How does finitude come to presence? How can we think of space and time as themselves figures of some nonfinite thing, figures of something "outside" a finite universe? Whence comes the light and the fire that, as Einstein remarks, "transfers mass" (*das Licht überträgt Masse*)?<sup>14</sup> Does the light of the fire bear an "outside" into the "inside"? Do any traces of an "outside" remain? If there are traces, are they merely unreadable remains or can we use them to reconstruct an "outside"? How can we think the difference of what lies *between* outside and inside? What is still hidden in the coming to presence of this light and in the transference of mass and energy by the fire of creation? Nietzsche's notion of the universe as cinder attempts to think the residual mass-energy of the outside that still burns on the inside.

When Derrida calls Nietzsche "something else perhaps than a thinker of the totality of entities," he is thinking of Heidegger's reading of Nietzsche as a thinker who succumbed to the metaphysician's desire to think the essence of the unhidden as something present, the desire to bring to presence the hiddenness from which all that is present emerged. Heidegger regards Nietzsche's notion of the "will to power," the essential or underlying force that determines the eternal recurrence of the finite universe over and over again, as a furious and futile imposition of the truth of beings upon the truth of Being: "The essential, historic culmination of the final metaphysical interpretation of beingness as will to power is captured in the eter-

nal recurrence of the same, captured in such a way that every possibility for the essence of truth to emerge as what is most worthy of question founders.”<sup>15</sup>

Derrida’s phrase, “something else perhaps than a thinker of the totality of entities,” indicates a certain departure from Heidegger’s position, at least insofar as it pertains to the cinder as the trace of Nietzsche’s effort to think not the essence of Being or beings but the difference between them; thus the cinder becomes the trace of a certain nonmetaphysical element in Nietzsche’s thinking. The cinder thus names thinking’s inability to achieve the metaphysical determination of the essence of unhiddenness.

The “*big bang*,” writes Derrida, “would have, let us say at the origin of the universe, produced a noise which we can regard as not yet having reached *us*. It is still to come and it will be up to us to capture it, to receive it.”<sup>16</sup> This ringing noise is still an absolute nonmemory, but it may not be so elsewhere, nor may it always be this way for us, or for those after us. Here and now, we cannot think beyond the borders of our finitude.

Nietzsche describes eternal recurrence as an image in a mirror, an image of the finitude of self-reflection, and thus also of its limits. At its limits, in the place of the tain of the mirror, lies the “nothing,” which “rings” the world into spatial form, between inside and outside, between a world and its concealed essence:

*And do you know what “the world” is to me? Shall I show it to you in my mirror? This world: a monster of energy, without beginning, without end; a fixed, brazen quantity of energy, which becomes neither bigger nor smaller, which does not consume itself [die sich nicht verbraucht], but only transforms itself; as a whole, of unalterable size, a household without losses and gains, but also without increases, without revenues; enclosed by “nothing” as by a boundary; not something vague or wasteful, not infinitely extended, but as a determined force enclosed in a determined space, and not a space*

*that would be “empty” anywhere, but rather as force everywhere, as a play of forces and waves of force, at once one and many, increasing here and at the same time decreasing there, a sea of forces storming and raging in itself, eternally changing, eternally running back, over monstrous ages of recurrence, with an ebb and flow of its forms, out of the simplest forms striving toward the most complex, out of the stillest, most rigid, coldest forms come forth the hottest, most turbulent, most self-contradictory, and then back home again from the most abundant to the simplest, from the play of contradictions back to the pleasure of concord [Einklangs], still affirming itself in this similarity of its courses and ages, blessing itself as that which must recur eternally, as a becoming that knows no satiety, no disgust, no weariness —: this, my dionysian world of eternal self-creation, of eternal self-destruction, this mystery world of twofold bliss; this, my “Beyond Good and Evil” without aim [Ziel], unless the joy of the circle is itself a goal, without will, unless a ring holds goodwill unto itself— would you have a name for this world? A solution to all its riddles? A light for you too, you most-concealed, strongest, most undaunted men of darkest midnight? — This world is the will to power — and nothing else! And even you yourselves are this will to power — and nothing else.”<sup>17</sup>*

Nietzsche forgets neither the distinction between *what* the world is and *that* it is nor between the world in the mirror and what

6 lies on the other side. The task he sets for himself, however, is to *name* this world, to name its “whatness” without mistaking it for the name of what is beyond the boundary that he calls the “nothing” (*Nichts*). The ebb and flow of the world as will to power is contained, surrounded (*umschlossen*), by a border (*Grenze*) that gives the universe the shape of a circle or a ring, a defined space in which a defined quantity of energy, heat, and light works its way through its incessant cycles of creation and annihilation. It is the voracious appetite of the world within the ring that Nietzsche calls “the will to power.” The formation of the ring itself, however, is, in Nietzsche’s extraordinary phrase, “without will” (*ohne Willen*), “unless a ring holds goodwill unto itself” (*wenn nicht ein Ring zu sich selber guten Willen hat*). The ring stands beyond the world as will to power, and thus bars the way to the essence of the truth of what comes to presence. In closing off our world, it opens onto something entirely other, something that goes entirely against the grain of Heidegger’s characterization of Nietzsche’s thinking: “As a revaluator of all values, Nietzsche testifies to the fact that he belongs ineluctably to metaphysics and thereby to its abyssal separation from *every possibility* of another commencement. Nietzsche himself does not know the distance that is measured out in this final step.”<sup>18</sup>

The ring is the name Nietzsche gives to the possibility of this other beginning. It is his name for this last step (*dieses letzten Schrittes*), this step that traces the nonpresent within presence, the step in which one finds oneself stepping up behind oneself, going not beyond but before, not into a metaphysical cosmology but back into the enigma of the everyday. Nietzsche, *pace* Heidegger, does know the unspeakable distance that this step measures out. The ring is between the world as will to power and the still withheld essence from which a world comes to presence. It names the unreflective foil on the other side of the mirror, what Heidegger, in discussing ancient Greek philoso-

phy, calls the *khorismos*, or “gap,” between Being and Becoming. In Nietzsche’s *Ring* we can hear the ringing of the *Klang*, the burning trace of an otherness that keeps a space open for the promise and the question of the truth of Being.

In Nietzsche’s account of the ring, there is a strange economy in this passage between the *Nichts* and the *wenn nicht* that inscribes the trace of another commencement, of a nothingness that is not nothing, of an “unless,” an “except when,” a hesitation, a proviso, a “but . . .,” that opens the *between* of the *khorismos*. Nietzsche writes the trace of something beyond the world in the world, something that appears only in disappearing, something that disappears into the thoughtful silence of the *wenn nicht*, as if to say, “but what if, on the other side of the ring . . .” The *Nichts* and the *wenn nicht* trace what Derrida calls a cinder, the trace here of a nonpresent “there,” the remains of the ring between outside and inside. Heidegger says that Nietzsche’s fundamental metaphysical position “can be the counterposition for our other commencement only if the latter adopts a *questioning* stance vis-à-vis the initial commencement – as one which in its proper originality is only now commencing.” Nietzsche’s putative ignorance of the “last step” serves as the pretext for the first step that is “the unfolding of a more original inquiry”:

*The thinker inquires into being as a whole and as such; into the world as such. Thus with his very first step he always thinks out beyond the world, and so at the same time back to it. He thinks in the direction of that sphere within which a world becomes world. Wherever that sphere is not incessantly called by name, called aloud, wherever it is held silently in the most interior questioning, it is thought most purely and profoundly.*<sup>19</sup>

Listening for the silent trace of another origin, for the ring of the nothing, for the accord (*Einklang*) of “the most interior questioning,” is precisely what Heidegger cannot discover in Nietzsche. We might call this Heidegger’s *pas de Nietzsche*, Nietzsche’s (non)step, Nietzsche’s “no,” or “no” to Nietzsche. It is in this destabilizing *pas de . . .*, in this step “out beyond the world, and so at the same time back to it,” that a cinder burns.

Heidegger speaks of the trace in terms of the mystery of presence that is concealed within the privative *a* of *a-letheia*, the coming into unhiddenness, coming from beyond the ring, coming from the other side of the *chorismos* into the world.<sup>20</sup> The privative *a* in Heraclitus’s *aletheia* or in Anaximander’s *apeiron* (the un-bounded) name the nameless exception, the withdrawal that is the coming to presence of a world.

The *a* in *différance* likewise marks the non-negative, nameless silence that dwells within the name, the trace of something irreducible to either presence or absence within the difference between Being and beings. At the same time, Derrida’s appropriation of this Heideggerian motif also disappropriates a vestigial echo in Heidegger’s usage of a certain apocalyptic promise that there is a final proper name to be discovered: “This is why the thought of the letter *a* in *différance* is not the primary prescription or the prophetic annunciation of an imminent and as yet unheard-of nomination. There is nothing kerygmatic about this ‘word,’ provided that one perceives its decapita(liza)tion. And that one puts into question the name of the name.”<sup>21</sup> Because we do not know whether or not there is a final proper name of Being, we will always hear a residual, silent promise of the name. What Derrida calls “an apocalyptic tone” is thus at once irresistible and menacing, a double bind. There is no way *not* to speak of “the name of the name.”<sup>22</sup> The task of putting into question the name of the name defines Derrida’s fundamental project from his earliest work to the present.

*Feu la cendre*, here translated as *Cinders*, was first published in 1982.

The enigmatic, untranslatable phrase *il y a là cendre* first appeared in the acknowledgments to *La Dissémination* in 1972. Derrida retrospectively traces anticipatory echoes of the phrase in “Plato’s Pharmacy” (1968), as well as post-1972 resonances of the phrase and the motifs it conveys in *Glas* (1974), *The Postcard* (1980), and “Telepathy” (1981), which is closely linked to the “Envois” section of *The Postcard*. Hence the shuttling back and forth from the left-hand pages, the “Animadversions,” a title which means “observations” or “assessments” and is of long standing in the history of criticism (Milton and Leibniz, for example, wrote texts using this title), and which gathers together the previously published allusions to cinders and ashes from texts written between 1968 and 1980, and the right-hand pages of *Cinders*, where we find the philosophical prose poem that was written in 1982 and that is woven around the phrase “cinders there are.” Which came first, the text written in 1982 or the antecedent passages that were gathered together in 1982 in response to the “newly” inscribed text of *Feu la cendre*? Which was the first step and which the last? Which is the cause and which the effect? The very construction of *Cinders* destabilizes the genealogical inquiry into antecedents and consequences in the very act of posing it. When did the gathering of cinders begin?

The “Animadversions” (as the Latin etymology suggests, “a turning of the mind toward”), gather together the trail of ashes toward which Derrida had always somehow been turning, gather together the cinders that had always been calling to him, calling for his attention. *Cinders* is the text in which Derrida finally answers the call.

On the way to answering the call, Derrida deciphered many of the names that the master thinkers from Plato to Heidegger have given to the difference within ontological difference, sometimes without having themselves realized precisely what they were naming. These paleonymic or deconstructive readings of the names of what is most ancient, ancient and modern names for what is older than time and space, these readings turn again and again to a primordial nonpresence that is not nothing, what Derrida calls in his reading of Husserl “the irreducible nonpresence of another now.”<sup>23</sup> *Verflechtung*, or “intertwining,” is the word in Husserl’s *Logical Investigations* that names

the destabilizing linkage within language between indication and expression, the irreducibility of what the sign shows prior to its appropriation by the *cogito* as an expressive means of establishing its own self-relation. Something in the sign pre-exists the ideal self-relation of the Husserlian *cogito* and in fact constitutes it rather than being constituted by it. The *Verflechtung* of indication and expression names the site of what Derrida, in his study of Husserl’s *The Origin of Geometry*, called “a degradation at the interior of language.”<sup>24</sup> The power of the sign to gather meaning and sense (*sens*) arises from this degraded nonpresence, this crumbling and fragile otherness of language that makes the sign “the worldly and exposed residence of an unthought truth”; the truth being that this something within language, which Derrida calls “writing,” causes the truth “to disappear.” What Derrida, still in the introduction to *The Origin of Geometry*, calls “la possibilité graphique,” marks the site of a persistent instability, an uncontainable divisibility within the very essence of language that is something other than language, that is something other than sensation and cognition. The inscription (*gramma*) and the letter (*grammata*) are always already engaged to, and in the service of, the divisibility of the trace that they bear within themselves as the very condition of their coming to presence. Writing (*écriture*) is the name Derrida gives to the nonpresence within the presence of the inscription and the letter. “The concept of writing,” as he remarks apropos of Rousseau’s *Essay on the Origin of Language*, “designates the place of unease [*lieu de malaise*], of the

regulated incoherence within conceptuality.”<sup>25</sup> This uneasy site lies within and beyond the graphite, within and beyond the carbonized remains of the fire; and it opens onto the divisible, unseizable, unthinkable graphematic possibility that lies immeasurably outside even while it leaves its barely discernible graphic trace on the inside. *Verflechtung*, “the supplement,” and writing are the names through which Husserl and Rousseau keep a space open for the coming of the other, names through which they at once mark the still withheld essence of language and at the same time attempt to appropriate it for thinking. In these and other readings by Derrida from the 1960s and 1970s one can hear the call of ash and cinders from within the graphic degradation of writing, which in effect already marks out the site of the remains of an absolute outside encrypted on the inside of language.

A “graphics of supplementarity,” a “generalized writing,” situated, as Derrida writes apropos of the chain of significations at work in Plato’s texts, “in the back room [*arrière-boutique*], in the shadows of the pharmacy, prior to the oppositions between conscious and unconscious, freedom and constraint, voluntary and involuntary, speech and language.”<sup>26</sup> The way to language leads into this back room, and it is here that ash and cinders burn. The essence of language has consumed itself as the condition of the coming to presence of phonic and graphic traces.

Plato’s Second Letter concludes with Plato admonishing his correspondent to burn the letter. In the first version of “Plato’s Pharmacy” Derrida writes, “reread this letter . . . burn it. And now, to distinguish between two repetitions.” Four years later, when the essay was published in *Dissemination*, Derrida made a slight change: “reread this letter . . . burn it. *Il y a là cendre*. And now, to distinguish between two repetitions.” Both versions are gathered in the “Animadversions.” “Cinders there are” between two repetitions, between the absolute space that

lies beyond the ring and the trace of that other materiality within the ring of empirical space. The other, unnameable materiality was already there, always on the outside, but its traces must also already be on the inside in order for the inside to come to presence. A cinder is what burns in language in lieu of the gift or the promise of the secret of that “first” burning, which may itself be a repetition. Something persists, something keeps ringing and burning between these repetitions; it is this something that gives the strange gift of a cinder.

“Yes, she cried, yes, yes.” The thought, the thing that cries here at the end of Maurice Blanchot’s *L’Arrêt de mort* (which means at once that which gives death, the “death sentence,” and that which stops it, keeps it at bay), is less a phenomenologically identifiable character than it is *la pensée, la chose* that lies within the ashes of the concealed origin of language: “And that now this thing is over there [*là-bas*], now you have unveiled it and, having seen it, you have seen face to face that which lives on for eternity, for yours and for mine!”<sup>27</sup> It is this voice that somehow speaks even within the ashes that Derrida calls *La Cendre*, the Cinder, as in Cendrillon, Cinderella, the one in Perrault’s fairy tale who is covered with ashes (“Cucendron,” as her nastiest stepsister calls her), the one who remains with the remains of what burns in the hearth. Derrida addresses her throughout *Cinders*, or rather, is addressed by her. “‘Viens,’” writes Blanchot, “et éternellement, elle est là” (“Come,” and eternally

she is there). *LA Cendre* is the Other, she affirms the first burning, the first lack (*LAC*), the first “without” that is not really nothing, and she is intertwined, interlaced, an *entrelac*, an interlacing, in the second burning, in all our memories, forgettings, appropriations, and disappropriations.

In *Parages*, *Ulysse Gramophone*, and several of the essays collected in *Psyche: Invention de l'autre*, Derrida pursues the issue of the double repetition through readings of Blanchot, Joyce, Michel de Certeau, Heidegger, and others.<sup>28</sup> *Cinders* announces the coming of the “arche-originary *yes*” through the coming of the phrase “Cinders there are,” through its double appearance in *Dissemination* and its repetitions and transformations in *Glas* and *The Postcard*. What Derrida in his reading of Joyce calls “the gramophone effect” is another name for the cinder, for the affirmation of the Other in the back room, the Other in the ashes, what Joyce calls the “gramophone in the grave,” the automatic, noncognitive writing that preexists the coming of the subject. The essays on Blanchot collected in *Parages* date from 1976 to 1979, while the two essays on Joyce in *Ulysse Gramophone* and the essays on the double “yes” in *Psyche* all follow the publication of *Feu la cendre* in 1982. The coming of the cinder that is the “arche-originary *yes*” is unspoken, inaudible, like the unseizable, unmasterable complex of terms generated in Blanchot’s texts by the *pas de . . .*, *pas-de-nom*, or *pas au-delà*, the nameless step of naming, or the step into an inaccessible beyond. *Là cendre*, with or without the accent, like the *pas de*, signals a pre-originary engagement or commitment, a promise or pledge, that silently binds language to the infinite divisibility of the nonpresent trace, and thus to the Other. In *Of Spirit* Derrida writes *langage* as *Pengage* to indicate our engagement to language as something that precedes all questioning, thinking, and speaking.<sup>29</sup> Cinders are the gage of this engagement, the self-consuming artifacts by which language pledges itself in the very act of immolating the promise it makes. It is the call of the cinder, the coming of *il y a là cendre*, that leads Derrida

from the “graphics of supplementarity” to the thought of the nonpresent Other.

*Cinders* recounts the *Ereignis* of language that doubles and divides every affirmation, every “yes,” placing it between two repetitions, between the Other’s silent call and the possibility of Its arrival.

### 3

*This mere word, spaced without space, affirming beneath all affirmation, impossible to deny, too weak to be killed, too docile to be contained, not saying anything, only speaking, speaking without living, without voice, in a voice lower than any voice.*

MAURICE BLANCHOT, *L'Attente l'oubli*

Derrida makes explicit what is merely implicit in Heidegger when it is a question of the intimacy and the remoteness of the Other, which also involves the question of the gender of the Other. She, the grammatical “she,” *la cendre*, is “eternally there,” which is to say, “eternally nonpresent.” The cinder is also at times “he.” As Derrida remarks in his essay on the gender of Dasein in *Being and Time*, “one must think of a pre-differential, rather a pre-dual, sexuality,” which situates sexual difference at an indeterminate point in the disseminal throw through which Dasein enters spatiality.<sup>30</sup> Dasein’s relation to the body is put into question throughout *Cinders*.

We might also think of the cinder as the “friend” of whom Heidegger speaks: “Hearing constitutes the primary and authentic way in which Dasein is open [*Offenheit*] for its ownmost potentiality-for-Being – as in hearing the voice of the friend whom every Dasein carries with it [*der Stimme des Freundes, den jedes Dasein bei sich trägt*].”<sup>31</sup> Dasein carries her/him, the cinder, the intimate and yet unspeakably remote friend, whose “pre-dual sexuality” (a kind of potentiality for gender) always accompanies the particular gender of a body in real space. Dasein is Dasein only insofar as the cinder is there; only insofar as Dasein hears the silent voice of the cinder can Dasein come to the word. S/he keeps her(him)self a secret while s/he lies within our most intimate interiority.

The cinder is not the word, it is not the letter, but what precedes it; and what precedes the letter has already been burned. The cinder comes in lieu of a preoriginary letter that would assure that a letter always reaches its destination, which would be to believe that the letter as language’s essence could be made present, could be given, to thought. The remains of a cinder prevent thinking and naming from reaching back before the fire: “this double gesture, to propose a philosophy of cinders and to show how ‘cinders’ prevent philosophy from closing upon itself.”<sup>32</sup> The cinder is neither an entity, nor Being, nor non-Being. Cinders remain of what lies beyond the ring, remain of what is not and was never in the world. The cinder is the dispatch of *envoi* whose incineration makes a letter possible.

But what separates a cinder from an *envoi* and from the other names for the structure of the trace is its evocation of the fire. The title *Feu la cendre* indicates, by virtue of its double displacement of the two meanings of *feu*, yet a further connection – to mourning: “fire,” but also “deceased” or “departed.” Among the options for a more literal translation are “Fire, Cinder,” “Burn the Cinder,” or “The Late Cinder,” “The Bereaved Cinder,” in the archaic sense of “bereaved” as “separated” or “taken away.” *Feu* is a homonym of *fut*, and echoes *fût*: fire

burning within the *passé défini* of the verb “to be,” within *l'être/lettre*. These echoes are elaborated in an essay from 1977 called “Cartouches,” which is about the artwork of Titus Carmel. *Cinders*, like Titus Carmel’s matchbox coffins, is a “cartouche,” a cinder container bearing the phrase *il y a là cendre*, a cinder *envoi* that is also an explosive cartridge (also *cartouche* in French), that commemorates the “firepower” of a nonpresent (divine) name, an exploded paradigm: “the suicide paradigm retrac(t)ing by blowing itself up. It scuttles [*saborde*]. *Fuit* [in Latin, ‘it was’; in French, ‘flees’ or ‘fled’] the former model. *Feu (sur) le paradigme* [fire on the paradigm; the late paradigm]. *Il-fût*.”<sup>33</sup> *Feu la cendre* takes this structure of aesthetic auto-destruction to its inevitable limits, where the contents of the cartouche, the phrase itself, autodestructs: “a self-destructive virtue firing on its own right into the heart.” From *feu le paradigme* to *feu la cendre*, from the deconstruction of aesthetic judgment to that of ontology. The cartouche and the cinder call upon us to mourn the lack of paradigms and holy names. But what is it to mourn the disappearance of something that was never present?

In a brief essay entitled “Transience” (*Vergänglichkeit*) (1916)<sup>34</sup> Freud recounts a conversation he had with a friend and a young poet whose “aching despondency” concerning the transience of earthly beauty was unaffected by Freud’s argument

that transience in fact only lends things greater charm. Freud's failure to persuade his companions suggests to him that they are influenced by "some powerful emotional factor" which he calls "a foretaste of mourning" (*einen Vorgeschmack der Trauer*). In *Glas* and *Fors* Derrida elaborates on the orality of the mourning process and on its connection to the introjection and incorporation of words, phonemes, and letters. For Derrida there is no introjection without incorporation, no idealization of the one who is departed that does not leave some unassimilable residue behind, some piece or fragment of the other or the other's speech secretly lodged or incorporated within the mourner's speech or behavior. This is also the case with language as such: we cannot take it in without also coming upon the unassimilable remains of the Other. It is this otherness of the word that Derrida calls the "bit," or *mors*, as in the "piece," or *morceau*, of the dead that one eats in a cannibalistic mourning ritual, a ritual that is in effect enacted whenever one comes to the word, for whenever one inhales or exhales the vocable, one also eats a piece of the word's otherness, of the departed Other it silently bears with it. To come to the word is incessantly to taste these cinder remains. Freud's concern in "Transience" is with the temporality of things, with one's mournful "foretaste" of "temporal limitation" (*zeitliche Beschränkung*). What makes mourning such "a great enigma" (*großes Rätsel*) is the pain caused by the "detachment" (*Ablösung*) of libido from the lost object: "We see only that libido clings [*klammert*] to its objects and will not renounce those that are lost even when a substitute lies ready to hand." It is the cinder beyond the word, other than the word, that nevertheless clings to the word, that is sprinkled on it and that burns within it. Mourning ends when "it has consumed itself" (*sich selbst aufgezehrt*) by eventually renouncing its former attachments. Derrida is interested in what persists within the "enigma" of mourning, of what still "clings," what still con-

tinues to burn and cannot be consumed. For Derrida mourning always entails melancholia, an infinite attenuation of the clinging to something "there." Freud writes in "Mourning and Melancholia" that both normal and melancholic mourning share the "characteristic of detaching the libido bit by bit" (*Einzeldurchführung*).<sup>35</sup> Derrida's name for this attenuated clinging is borrowed from the nineteenth-century convention of *demi-deuil*, the "half" or "partial mourning" that follows "high mourning." For Derrida we are always already in half mourning, for there is no end to the "bit by bit" divisibility of a cinder. Pushing still further Abraham's linguistic elaboration of Imre Hermann's study of libidinal clinging (*cramponnement*),<sup>36</sup> Derrida discovers the clinging to language of something beyond language: the clinging of the bit, the *mors*, which is also of course the *mort*, the dead. What in *Glas* Derrida calls the *effet de mors*, the "bit-" or "death-effect," the effect of the *gl* (as in glottis), the *clinging*, sticky work of the tongue that at once makes possible and resists absolutely all idealization and conceptualization,<sup>37</sup> this *call* of something entirely other from within the silent ringing of *glas*, takes in *Cinders* the form of a "raw cinder, that is more to his taste."

But there is still something more to this name among others that is a cinder. *Cinders* "would tell of the all-burning, otherwise called holocaust and the crematory oven, in German in all the Jewish languages of the world." The work as cartouche commemorates "an impossible tomb"; it constitutes "the memory of a cenotaph," an inscription on an empty tomb.

When Hegel writes in *Phenomenology of Spirit* and *Lectures on the Philosophy of Religion* of the torrents of fire and light, of the

“streams of fire destructive of [all] structured form,”<sup>38</sup> he calls the coming of the all-burning light of sunrise a “sacrifice” (*Opfer*) in which the Being-for-itself of spirit burns itself, consumes itself in order to preserve itself. Derrida suggests in *Glas* that “holocaust” is a better translation of *Opfer* than “sacrifice” and indeed that “holocaust” (all [*holos*] is burned [*caustos*]) is a more appropriate word for the process Hegel describes than *Opfer* itself. Derrida’s holocaust means something different, however, than Hegel’s *Opfer*. In Hegel’s speculative dialectic the holocaust is spirit’s gift of itself to itself; its excursion into what Hegel calls its “otherness” only insures its return to itself. For Hegel, writes Derrida, “The gift can only be a sacrifice, that is the axiom of speculative reason. Even if it upsurges ‘before’ philosophy and religion, the gift has for its destination or determination, for its *Bestimmung*, a return to self in philosophy, religion’s truth.”<sup>39</sup> Hegel’s sacrificial holocaust makes the otherness of the holocaust itself *appear*, it pretends to bring it to presence, while Derrida’s holocaust remains entirely other, nonpresent and outside the theorizable limits of ontology, leaving only the cinder traces of an absolute nonmemory. It is the *non*-sacrificial nature of the Nazi Extermination that is silently at stake throughout the section of *Glas* that forms the central and longest section of the “Animadversions.” A certain continuity is thus also (and still silently) sketched between Hegel’s sacrificial logic, which ontologized the essence of unhiddenness, and the aesthetic or cathartic motivation of the Nazi Extermination, the most monstrous gift of appropriation, which sought to purge Europe of its unaesthetic inhabitants, Jews above all, but also dissidents and eccentrics of all sorts – political, sexual, or cultural; “of the others,” writes Derrida, “cinder there is.”

Cinders resist the domination of the essence of unhiddenness by the dialectic, by mind, reason, spirit, etc. In so doing, they eliminate the possibility of the anniversary, the return back to

itself, of spirit, energy, will, form, etc. Can we think the otherness of what is outside the ring, think of it as something that can never come back to itself? Thinking what Derrida calls “the time of a cinder” denies us the consolation of “the logic of the anniversary, the imposition of the curve on the angle.”<sup>40</sup> It means thinking the ring’s displacement from itself, “dispersion without return,” a truly “pyromaniac dissemination.” One thus commemorates a cinder’s not-belonging to itself, another kind of anniversary, the anniversary of an absolute nonmemory, the ringing together of what no longer takes the shape of a circle.

Mourning, ashes, the holocaust, the breathing in and eating of the remains of cinders, the anniversary, the ring, the absolute singularity of the date, these elements of *Cinders* all signal the pervasive influence of Paul Celan. In *Schibboleth: Pour Paul Celan* we read: “Il y a la cendre, peut-être, mais une cendre n’est pas” (There are cinders, perhaps, but a cinder is not). The passage continues: “This remainder *seems* to remain of what was [*fut*], and what was [*fut*] just now; it seems to feed or drink from the source of being-present, but it comes out of being, it uses up in advance the being on which it seems to draw. The remnant of the remainder – the cinder, almost nothing – is not a being that remains, if at least one understands here a being that subsists.” This passage is by way of a reading of Celan’s “Mit der Aschenkelle geschöpft” (Drawn with the ladle of cinders / from the trough of Being): “What is drawn, inhaled, drunk (*geschöpft*) with the ladle (*Kelle*; the source or the fountain, *Quelle*, is not far), with the ladle of cinders, with the cinder spoon (*mit der Aschenkelle*), comes out of the trough of Be-

ing (*aus dem Seinstrog*).<sup>41</sup> The cinder ladle comes out of Being *seifig*, soapy, slippery, a slippery cinder, nearest the source of Being but most difficult to grasp. The process by which the cinder serves up the word describes the central scene of Celan's writing: the coming again and again of the cinder that bears the word, and that, in bearing the word, consumes it. Derrida's holocaust is identical with the radical nonidentity of the ringing of an anniversary in Celan:

*Consumption, becoming a cinder, conflagration or incineration of a date: on the hour, in the hour itself, every hour. It is the threat of an absolute crypt: the non-return, the unreadability, the amnesia without remainder, but the non-return as return, in the return itself. [. . .] There is certainly today a date for this holocaust that we know, the hell of our memory; but there is a holocaust for every date, somewhere in the world at every hour.*<sup>42</sup>

The ringing of this anniversary cuts into the word, incises the ring at an angle, circumcises the word (which is Derrida's leitmotif in *Schibboleth*): "circumcision of the word by the incision of the nothing in the circumcised heart of the other, that's you," that's the cinder, the friend of uncertain gender who always accompanies Dasein.<sup>43</sup> All languages are Jewish in this sense, consumed by the cinder that bears them and burns them from within, by the all-burning oven named in the Greek *holokaustos* "in German in all the Jewish languages of the world."

#### 4

*How is it called, your land  
behind mountains, behind years?*

PAUL CELAN, "Es ist alles anders"

Celan's oblique presence in *Cinders* is one of the most finely nuanced inflections by which Derrida defines his own neighborhood of poetic naming and thoughtful saying. The cassette recording that accompanies the 1987 French edition, in which

the author and Carole Bouquet read *Feu la cendre* with the occasional accompaniment of Stockhausen's hauntingly ethereal *Stimmung*, brings the question of thinking and poetry directly to bear upon what Derrida calls the "polylogue," "an unpronounceable conversation," between the audible sonority of the indeterminate number of voices of *Cinders* and the still silent voice, the absolutely minimal voice of the Other. "But how," asks Derrida, "can this fatally silent call that speaks before its own voice be made audible?" The various tonalities and moods of voice, already marked in the written text and still more discernible in the recorded version, succeed in making the inaudible call of the Other yet more discernible, by always calling, in all their multiplicity and gender confusion, for yet another voice, for one that would bring us still closer to the "you" that speaks in a cinder. Cinderella is one name among others for the still withheld essence of the cinder friend that is borne along with Dasein. By varying the intonation, by trying to mark or to efface the *accent grave* in *là cendre* (which sometimes even looks like an anagram of *ce(la)n*), the spoken voices begin, as Derrida remarks, to say something about "the experience of cinders and song." The song of poetic saying would thus sing to and of the inaudible, nonpresent incineration that burns within every experience: "this experience of incineration that is experience itself."<sup>44</sup> We can only think the otherness of the other's inaudible voice, but our thinking about it is always inseparable from poetic saying, from the audible song, prayer, or hymn that would bring us as close as possible to the silence in which the voice of the Other burns. *Cinders* is situated in the neighborhood of this haunted crossing, in the nearness of the *khorismos*, near what Derrida calls "the absolute hiatus."

The neighborhood of *Dichten* and *Denken* is convened by the Other's silent call. "But poetic saying that thinks [*das denkende Dichten*]," writes Heidegger, "is in truth / the topology of Being [*Seyns*]."<sup>45</sup> Such saying, Heidegger continues, "tells [*sagt*] Being the habitation [*Ortschaft*] of its essence [*Wesens*]," its still concealed essence. Being comes into the proximity of poetic saying and thinking and thus establishes and signals its topology, the place it has come to inhabit, the place (*Ort*) that is distinct from space (*Raum*). This is what occurs in the coming of the phrase *il y a là cendre*, the phrase that establishes and signals a place (*il y a lieu* / Place there is), a place that is not to be conceived or experienced spatially. What Derrida calls the "locality" (*le paysage*) of "cinders there are" suggests the habitation or topology of a cinder that is evoked in the words *Ortschaft* and *Nachbarschaft*. The neighborhood of poetic saying and thinking is a place or site that belongs to the topology of another spatiality which Derrida and Heidegger (re)name and (re)think throughout their writing. The specific modalities of the naming and thinking of that neighborhood point to important resemblances and differences between Heidegger and Derrida which bear significantly upon the tonality of *il y a là cendre*.

*Là cendre* names the persistent concealment of Dasein's essence, indeed it translates that concealment into French; *là-cendre* at once translates and reconfigures *da- Sein*. Like Dasein a cinder lies within the difference of the unextended space of the *res cogitans* or "thinking thing" and the extended space of the *res extensa*, within the difference between the intelligible and the sensible; it is what makes cognition possible while withholding itself from representation or conceptualization. A cinder lies finally on the far side of Dasein, just beyond the edge of its Being-in-the-world. It thus follows the trajectory of Heidegger's effort to name and think the word that would bring to presence, that would distance and "un-distance" (*ent-fernen*) the "region" (*Gegend*) in which Being comes to language. By

situating the places in language where Being comes to reside, such naming and thinking bring Being into the audible range of beings who can thus be called into their own. To discover these traces, grooves, and effractions in language through which Being marks its silent withdrawal is to come to the liminal threshold of the site of this other spatiality that is composed of another materiality, a spatiality into which three-dimensional space and time emerge, and that, in gathering together and sustaining the differences between past, present, and future, would constitute another temporal or extratemporal dimension. Heidegger asks us to think of the concealed origin of language as being situated on this dimensional cusp. His later thinking searches, listens, and lingers within language for traces of what in *Being and Time* he called Dasein's capacity to "take space in," or to "break into space." Instead of asking how Dasein could enter time-space, the later Heidegger asks what it is that enables time-space to get underway. Moving from the near to the far side of the ontological difference, moving from Dasein to language, Heidegger seems at times to write as though the final, absolutely literal proper name for the materiality of this other space-time were near to hand, as though it were on the verge of becoming palpable.

What in *Being and Time* he calls the "spiritual" (*geistig*) essence of Dasein's ability to become spatial,<sup>46</sup> belies a profound commitment to the possibility of such naming. As Derrida demonstrates in *Of Spirit*, *Geist* names, in early and late Heidegger,

the site of the proximity of Being's proper name, the site of fire and ashes. Whereas in *Being and Time* it is the spiritual (*geistig*) essence of Dasein's "ecstatic-horizonal temporality" that enables it to break into space, in "Language in the Poem" that essence burns within the mystery of ghostly or *geistlich* fire. Spirit as fire leads Heidegger closer to that other materiality than had spirit as the breath of mind and thought. Rejecting the *geistig* thinking of Platonism and Christianity, as well as his own earlier celebration of the *geistig* force of Dasein and the German people, Heidegger, in a gesture whose intemperate impatience Derrida devastatingly reveals, turns to Trakl's *geistlich* land: "This land is older, which is to say, earlier and therefore more promising [*versprechender*] than the Platonic-Christian land, or indeed than a land conceived in terms of the European West. For apartness is the 'first beginning' of a mounting world-year, not the abyss of decay."<sup>47</sup> Heidegger wants to come as close as he can to the fire of the promise that burns within language, always closer to the inmost materiality of the fire. His advocacy of Dasein's *geistig* essence during the 1930s had, perhaps inadvertently, provided cover for the forces of destruction. Perhaps the haunting return of *Geist* in its fiery, *geistlich* guise would lead, not to the decay of a decomposing *Geschlecht*, but to the "mounting world-year" of "one flesh."

This "more promising" beginning, whatever its salutary utopian possibility, involves a promise no less impossible than the erstwhile promise of its *geistig* predecessor. Invoking the memorable and ineluctable wrinkle which Paul de Man introduced into Heidegger's famous formula, *Die Sprache spricht* (language speaks), Derrida remarks that de Man's *Die Sprache verspricht sich* addresses precisely the problem that Heidegger's differentiation of *Geist* has led him into:

*Language or speech promises, promises itself but also goes back on its word, becomes undone or unhinged, derails or becomes delirious, deteriorates, becomes corrupt just as immediately and just as essen-*

*tially. It cannot not promise as soon as it speaks, it is promise, but it cannot fail to break its promise – and this comes of the structure of the promise, as of the event it nonetheless institutes.*<sup>48</sup>

This deterioration, this fragility of language, this degradation at the heart of language, is something Heidegger everywhere confronts only to turn away from it at the last moment. Heidegger wants to think of *Geist* at its most essential as being somehow free of the decomposition of human generation, while Derrida's deconstructive reading shows that the most *versprechende* beginning is nevertheless heir to the corruption of language.

Cinders name this corruption, they anticipate language's inevitable crumbings and deteriorations. Though, arguably, no one has understood better than Heidegger the delicacy of language and its susceptibility to breakdowns and misfires, denials and negations, indeed the entire network of terms and ideas that can be generated from *versagen*, this understanding is invariably placed in the service of an even more profound susceptibility to the lure of the finally proper name.<sup>49</sup> *Cinders*, however, plays with the tormenting will to speak the proper name. Derrida plays with the deadly serious proximity and distance of the fire that burns and subsides within a language. The "continuous, tormenting, obsessive meditation about what are and are not, what is meant – or silenced by, cinders" moves incessantly from mourning to telepathy, from the most impossible distance to the most unbearable proximity. Derrida's cinders

cannot escape or overcome the promise of, and the desire for, the literal name, but by anticipating the broken promise, by remaining alert to the trope lurking within every concept and the concept concealed within every trope, they inject a certain restless instability that may make it inevitable as well as necessary that we constantly invent new versions of the Other and thus of the others.

Language rises like a wave out of its unthinkable origin and comes into the linguistic habitations (the *Ortschaft*) of human speech or into the *Gedicht* of the poet. It is up to thinkers to make these habitations audible, and up to poets to discover the song within these traces. The rising itself is a silent ringing, a hissing noise, like heat escaping, like something burning, a wave of agitated motion which thinkers and poets translate into differing modes of audibility. As this wave rises from its impossible distance, mourning becomes telepathy, and we receive what Derrida calls "the impossible emission." *Tele-pathos*, the transmission over a distance of the Other's state of being, the ability to feel the heat of the Other, is more properly speaking *tele-kaustos*, the sending of what burns within a cinder. *Telekaustos* would mean, not thought-transference, but the transference of that other materiality within thought which at once sustains thought and withholds itself from thought. The opening of another topology through language is the work of *telekaustos*, the sending of a cinder signal.

Early and late Heidegger succumbed to the persuasive power of *Geist*. And early and late in his writing there is a clearly defined sacrificial logic. In order to define perhaps the most significant feature of *Cinders*, let us consider a characteristic instance of Heidegger's understanding of the relation between "historical being" and the advent of the essential thinking that thinks the truth of Being:

*The thinking whose thoughts not only do not calculate but are really [überhaupt] determined by what is Other than beings [dem An-*

*deren des Seienden] is called essential thinking. Rather than count on beings with beings, it expends itself in Being for the truth of Being. This thinking answers to the demands of Being in that man surrenders [überantwortet] his historical being to the simple, sole necessity whose constraints do not so much necessitate as create the need which is fulfilled in the freedom of the sacrifice [Freiheit des Opfers].<sup>50</sup>*

It is through one's courage to make the sacrifice, Heidegger continues, that one enters into "the neighborhood of the indestructible." The thinker's "saying" of Being and the poet's "naming of the holy" seek, in their distinct ways, "to care for" the words in which Being's "soundless voice" rings. This statement of the sacrificial logic underlying the neighborhood of *Dichten* and *Denken*, which Heidegger wrote in 1943, makes explicit the fundamental content of Heidegger's thinking before and after. Sacrifice entails that we must reconfigure our historical being once we have entered into relation with the truth of Being, even if that truth is still only the trace of something lacking and withheld. There would be nothing particularly alarming about such a scenario were it not for the fact that Heidegger's "essential thinking" lavishes itself, indeed squanders itself (*verschwendet sich*) on the truth of Being. This is how he had endorsed the *geistig* essence of German Dasein, and how he will endorse the coming of a *geistlich* epoch in his later writing. There is nothing left for historical being but the prospect of its imminent cessation as the logic of sacrifice bears essential thinking ever closer to the fire of the spirit.

The disengagement of Heidegger's thinking from the sacrificial logic underlying it has been an important part of Derrida's

18 thinking early and late. Derrida recognized very early that the only way to enable essential thinking to reconfigure historical being was to remove it from the logic of sacrifice. The relation between logic and sacrifice is of the utmost importance here, for it is Heidegger's intention to mark an absolute break between logic, or "calculative thought," and sacrifice, which involves our submission to those prelogical thoughts that "are absolutely [*überhaupt*] determined by what is 'Other' than what-is." Heidegger insists that "sacrifice tolerates [*duldet*] no calculation, for calculation always miscalculates [*verrechnet*] sacrifice in terms of the expedient and the inexpedient."<sup>51</sup> It has always been clear to Derrida that Heidegger's sacrifice on behalf of the Other provides cover for the most calculating ideological and psychological investments. Heidegger's sacrifice to the Other lends itself too readily to a calculated sacrifice of the others who do not appear to share the experience of essential thinking. Heidegger even calls the sacrifice "the departure from beings [*Abschied vom Seienden*]." While for Heidegger "calculation disfigures [*verunstaltet*] the nature of sacrifice," for Derrida the insurmountability of miscalculation and disfiguration exposes the dangers of the surreptitious logic of sacrifice. Derrida reveals the secret economy of loss and gain that sustains even the sublime fiction of a sacrifice *à fond perdu*. She, the Cinder, blocks the path of Heidegger's impossible sacri-

ifice. Heidegger would risk everything on the withheld origin of the "call of conscience" that comes from Dasein's innermost essence, from the being "there."<sup>52</sup> Derrida wants only to take a chance on the Other, to reveal that no sacrifice will succeed in bringing the Other to presence, and to acknowledge that the experience of a cinder describes our *ethos*, our "dwelling-place" as human beings. Derrida listens more closely than Heidegger and discerns the almost inaudible call of the Cinder, its strange androgynous intonation. Derrida's recognition or acknowledgement of our debt to the Other purges Heidegger's thinking of its Romantic apocalypticism and thus provides us with a realistic basis on which to rethink and reinvent our relations to others. Though it is not yet present and may never be present, the place of the Other is nevertheless real, and through it we can deconstruct the transcendent idealities and materialities that pretend to bring it to presence.

*Cinders* is the *for intérieur* of Derrida's oeuvre, where he hears the "lack" that comes like a whisper from the far side of Dasein, from the distant entity beyond Being that holds everything in Being. *Cinders* recounts the emergence of conscience as the recognition of our debt to the Other and to the others. "That is what is owed to the fire, and yet, if possible, without the shadow of a sacrifice." These words from *Cinders* may provide the best clue to translating the enigma of *il y a là cendre*.

P r o l o g u e

Il y a plus de 15 ans, une phrase m'est venue, comme malgré moi, revenue plutôt, singulière, singulièrement brève, presque muette.

Je la croyais savamment calculée maîtrisée, assujettie, comme si je me l'étais à tout jamais appropriée.

Or depuis, sans cesse je dois me rendre à l'évidence: la phrase s'était passé de toute autorisation, elle avait vécu sans moi. Elle avait toujours vécu seule.

La première fois (était-ce la première fois?), ce fut donc il y a plus de 15 ans, à la fin d'un livre, *La dissémination*. Dans un paragraphe de remerciements, au moment où un livre se dédicace, se donne ou se rend à ceux qui, connus ou inconnus, vous l'ont d'avance donné ladite phrase vient s'imposer à moi avec l'autorité, si discrète et simple qu'elle fût, d'une sentence: *il y a là cendre*.

Là s'écrivait avec un accent grave: *là*, il y a cendre, il y a, *là*, cendre. Mais l'accent, s'il se lit à l'œil, ne s'entend pas: il y a là cendre. A l'écoute, l'article défini, *la*, risque d'effacer le lieu, la mention ou la mémoire du lieu, l'adverbe là . . . Mais à la lecture muette, c'est l'inverse, *là* efface *la*, *la* s'efface: lui-même, elle-même, deux fois plutôt qu'une.

Cette phrase, dont chaque lettre en secret comptait pour moi, je l'ai ensuite reprise, citation ou non, dans d'autres textes: *Glas*, *La carte postale*, par exemple.

More than 15 years ago a phrase came to me, as though in spite of me; to be more precise, it returned, unique, uniquely succinct, almost mute.

I thought I had calculated it cunningly, mastered and overwhelmed it, as if I had appropriated it once and for all.

Since then, I have repeatedly had to yield to the evidence: the phrase dispensed with all authorization, she had lived without me.

She, the phrase, had always lived alone.

The first time (was it the first time?), more than 15 years ago, at the end of a book, *Dissemination*, in the acknowledgments, where a book is dedicated, offered, rendered up to those who, known or unknown, have already given it to you in advance, the sentence in question imposed itself upon me with the authority, so discreet and simple it was, of a judgment: "cinders there are" (*il y a là cendre*).

*Là* written with an accent grave: *là*, there, cinder there is, there is, there, cinder. But the accent, although readable to the eye, is not heard: cinder there is. To the ear, the definite article, *la*, risks effacing the place, and any mention or memory of the place, the adverb *là* . . . But read silently, it is the reverse: *là* effaces *la*, *la* effaces herself, himself, twice rather than once.

This sentence, in which each letter had a secret meaning for me, I used again later, whether a citation or not, in other texts: *Glas*, *The Postcard*, for example.

Pendant près de dix ans, allées et venues de ce spectre, visites inopinées du revenant. La chose parlait toute seule. Je devais m'expliquer avec elle, lui répondre – ou en répondre. Quand des amis, en 1980, m'ont invité à écrire sur le thème de la cendre pour une revue qui a maintenant disparu, *Anima*, j'ai proposé, dans le genre parodié du polylogue, une conversation apparemment imprononçable, en vérité un dispositif d'écritures qui, pourrait-on dire, *faisait appel* à la voix, à des voix. Mais comment faire entendre cet appel fatalement silencieux qui parle avant sa propre voix? Comment le laisser attendre?

Sur la page, en effet, deux écrits se font face: d'une part, à droite, le polylogue proprement dit, un enchevêtrement de voix en nombre indéterminé, dont certaines paraissent masculines, d'autres féminines, et cela se marque parfois dans la grammaire de la phrase. Ces signes grammaticaux sont lisibles mais ils disparaissent pour la plupart à l'audition, ce qui aggrave une certaine indécision entre l'écriture et la voix, indécision dont le mot *là*, avec ou sans accent, dans *il y a là cendre*, faisait déjà courir le risque.

Cette tension risquée entre l'écriture et la parole, cette vibration de la grammaire à la voix, c'est aussi l'un des thèmes du polylogue. Celui-ci semble-t-il, se destinait à l'œil, il ne s'accordait qu'à la voix intérieure, une voix absolument basse.

For nearly ten years, this specter's comings and goings, unforeseen visits of the ghost. The thing spoke all on its own. I had to explain myself to it, respond to it – or for it.

When some friends, in 1980, invited me to write on the theme of cinders for *Anima*, a now defunct journal, I proposed, in the parodied genre of the polylogue, an apparently unpronounceable conversation, really a writing apparatus that, one might say, *called* to the voice, to voices. But how can this fatally silent call that speaks before its own voice be made audible? How could it be kept waiting any longer?

In effect two pieces of writing come face to face on the page: on the righthand side, the polylogue proper, an entanglement of an indeterminate number of voices, of which some seem masculine, others feminine, and this is sometimes marked in the grammar of the sentence. These readable grammatical signs disappear for the most part when spoken aloud, which aggravates a certain indecision between writing and voice, an indecision already risked by the word *là*, with or without the accent, in "cinders *there* are" [*il y a là cendre*].

This tension risked between writing and speech, this vibration of grammar in the voice, is one of the themes of the polylogue. And this polylogue, it seems, is destined for the eye; it corresponds only to an interior voice, an absolutely low voice.

Mais par là même il donnait à lire, il analysait peut-être ce qu'une mise en voix pouvait appeler et à la fois menacer de perdre, une profération impossible et des tonalités introuvables. Oserai-je dire de mon désir qu'il avait lieu, son lieu, entre cet appel et cette menace? Qu'attendait-il?

Vint un jour la possibilité, il faut dire la chance de cette gramphonie. Avant d'être technique (ce qu'elle est aussi à un moment d'innovation singulière dans l'histoire de l'édition), cette chance suppose le désir, ici celui d'Antoinette Fouque: frayer le passage à ces voix qui travaillent une écriture au corps. Et en somme les mettre en œuvre, enfin à l'œuvre. Non pour substituer la scène vocale au livre, mais pour donner à l'une et à l'autre, l'une et l'autre s'affectant ou se relançant ainsi, leur espace ou plutôt leur volume *respectif*: je ne crois pas que la lecture silencieuse en souffre, ni le désir du livre, au contraire, il reçoit de cette expérience de nouvelles puissances interprétatives. Les éditions *Des femmes* ne proposent pas seulement ce double médium, la page et le volume sonore, désormais indissociables dans leur hétérogénéité même, elles donnent son lieu à une sorte de laboratoire d'études, un studio des écritures vocales, dans lequel une expérience de l'interprétation devient possible.

A quelle expérimentation nous sommes-nous donc livrés ensemble, Michèle Muller, Carole Bouquet et moi-même?

But precisely thereby [*par là*] the polylogue engaged reading; it analyzed perhaps what vocalization [*mise en voix*] could call forth and at the same time risk losing, an impossible utterance and undiscoverable tonalities. Will I dare to say that my desire had a place, its place, between this call and this risk. What was it waiting for?

Then one day came the possibility, I should say the chance of making a tape-recording of this. Before the technical means (which themselves mark a moment of singular innovation in the history of publishing), this opportunity presupposes the desire, here that of Antoinette Fouque: to breach a way into the voices at work in a body of writing. And in short, to situate them in the work, indeed to put them to work. Not in order to substitute the vocal setting for the book, but to give to each of them their space or rather their *specific* volume, in such a way that each medium is affected or reinvented by the other. I do not believe that silent reading will suffer from this, nor the book's desire, which, on the contrary, receives new interpretive impetus from this experiment. *Des Femmes* proposes not only this double medium, printed page and tape recording, from here on indissociable in their very heterogeneity, but also provides a place for it, a sort of research laboratory, a *studio* of vocal writing, in which an interpretive experiment becomes possible.

On what experiment have we embarked together, Michèle Muller, Carole Bouquet and myself? We have

Car sur la page, c'est comme si chaque mot était choisi puis placé de telle sorte qu'aucune profération par aucune voix jamais n'y accède.

Dans certains cas, en l'absence d'exigences marquées et contradictoires, c'est l'indétermination même qui rendait périlleux le passage à l'acte gramphonique: trop de liberté, mille façons, toutes aussi légitimes, d'accentuer, de marquer le rythme, de faire varier le ton.

Dans d'autres cas, qu'il s'agisse encore de césure, de pause ou d'accord, les décisions les plus contradictoires étaient simultanément requises: la même syllabe *doit* être prononcée sur des registres *incompatibles*. Et donc ne le doit pas. Cette potentialité peut rester, si on peut dire, dans le fond, et se percevoir à la lecture silencieuse, précisément, enveloppée, voilée. Comment la faire sortir de sa réserve sans un acte de foi, le hiatus absolu à l'instant d'une décision impossible? Celle-ci se trouve toujours confiée, le moment venu, à la voix de l'autre. Non, à *une* voix de l'autre, à une autre voix: celle, ici, de Carole Bouquet.

put this question to the test – at once fearful and defiant: Under what conditions does one take the risk of vocalization, the very act I had awaited, having already described it, given notice of it, above all dreaded it as the impossible itself, some would say the “prohibited” [*l'interdit*]? On the page it is as though each word were chosen, then placed in such a way that nothing uttered by any voice could gain access to it.

In certain cases, in the absence of indications to the contrary, it is the indetermination itself that makes the experience of the gramphonic act so perilous: too much freedom, a thousand ways, all just as legitimate, to accentuate, to set the rhythm, to make the tone change.

In other cases, where it is still a question of cesura, pause or agreement, the most contradictory decisions were required simultaneously: the same syllable *should* be pronounceable on two *incompatible* registers. But then again it shouldn't be. This potentiality remains, so to speak, in the background [*dans le fond*], to be perceived by silent reading precisely as something enveloped, veiled. How can we force this potentiality out of hiding without an act of faith, the absolute hiatus at the moment of an impossible decision? This decision is always confided, when the time comes, to the other's voice. No, to *a* voice of the other, to another voice: here, that of Carole Bouquet.

Who will decide whether this voice was lent, returned, or given? And to whom?

By entangling itself in impossible choices, the spoken "recorded" voice makes a reservoir of writing readable, its tonal and phonic drives, the waves (neither cry nor speech) which are knotted or unknotted in the unique vociferation, the singular range of another voice. This voice, to narrow the possibilities, is then left to pass away, it has passed away in advance, doubly present memory or doubly divided presence.

What is involved in this phonographic act? Here's an interpretation, one among others. At each syllable, even at each silence, a decision is imposed: it was not always deliberate, nor sometimes even the same from one repetition to the other. And what it signs is neither the law nor the truth. Other interpretations remain possible – and doubtless necessary. Thus we analyze the resource this double text affords us today: on the one hand, a graphic space opened to multiple readings, in the traditional and protected form of the book – and it is not like a libretto, because each time it gives a different reading, another gift, dealing out a new hand all over again – but on the other hand, simultaneously, and also for the first time, we have the tape recording of a singular interpretation, made one day, by so on and so forth, at a single stroke calculated and by chance.

To decide, sometimes without wanting to, between

Ils accompagnent, ils comparaissent: archive incomplète, encore en train de brûler ou déjà consumée, rappelant certains lieux du texte, la méditation continue, harcelée, obsédée de ce que sont et ne sont pas, veulent dire – ou taire, des cendres. Ces citations sont précédées du mot *animadversio* qui signifie en latin *attention, observation, remarque, rappel*, et que j'ai choisi en hommage à la revue *Anima*.

several interpretations (in the sense of reading that is also that of music and theater): the voice does not betray a text. If it did, it would be in the sense that betrayal is a revelation: for example, the restless polylogue that divides up each atom of writing. Manifestation of the impossible truth on which it will have been necessary, at every instant, and despite repetitions, to decide once and for all. The utterance thus betrays, it unveils what will have, one day, carried it away, between the divisions of all the voices or those into which the same voice divides itself.

Facing the polylogue, on the lefthand page, citations from other texts (*Dissemination, Glas, The Postcard*<sup>1</sup>) that all say something about the cinder, mingle their ashes and the word "cendre" with something else. The citations co-appear along with it, they are "summoned" [*comparaissent*]: an incomplete archive, still burning or already consumed, recalling certain textual sites, the continuous, tormenting, obsessive meditation about what are and are not, what is meant – or silenced by, cinders. These citations are preceded by the word *animadversio*, which in Latin means "observation," "perception," or "call to attention," and which I chose in homage to the journal *Anima*.

1. Although it is not cited, another text is alluded to (p. 75): "Télépathic," a kind of supplement to *The Postcard*, which, like *Glas*, is woven around the letters LAC, CLA, ALC, CAL, ACL, etc. (*Furor* 2 [1981] and *Confrontation* 10 [1983]). *Schibboleth* (1986), also dedicated to cinders, was not yet published.

Qu'on me permette de souligner enfin deux difficultés parmi d'autres dans la scénographie sonore qui fut tentée d'autre part. Tout d'abord, il fallait à la fois marquer et effacer l'accent sur le à de là dans "il y a là cendre" et ailleurs. Faire les deux à la fois était impossible et si le mot "accent" dit quelque chose du chant, c'est l'expérience de la cendre et du chant qui cherche ici son nom.

Puis si la version enregistrée donne à entendre deux voix, dont l'une paraît masculine, l'autre féminine, cela ne réduit pas le polylogue à un duo, voire à un duel. Et en effet la mention "une autre voix," qu'on entend parfois sans la lire, aura souvent la valeur d'une mise en garde. Elle signale que chacune des deux voix se prête à d'autres encore. Je le répète, elles sont en nombre indéterminé: celle du signataire des textes ne figure que l'une d'entre elles, et il n'est pas sûr qu'elle soit masculine. Ni l'autre femme.

Mais les mots "une autre voix" ne rappellent pas seulement la multiplicité des personnes, ils appellent, ils demandent une autre voix: "une autre voix, encore, encore une autre voix." C'est un désir, un ordre, une prière ou une promesse, comme on voudra: "une autre voix, que vienne à cette heure, encore, une autre voix. . . ." Un ordre ou une promesse, le désir d'une prière, je ne sais pas, pas encore.

May I emphasize finally two difficulties among others in the resonant scenography that was attempted elsewhere. To begin with, it was necessary at once to mark and efface the accent on the "à" in "là" in "il y a là cendre" and elsewhere. To do both at once was impossible and if the word "accent" says something about "song," it is the experience of cinders and song that here seeks its name.

So if the recorded version makes two voices heard, of which one seems masculine, the other feminine, that does not reduce the polylogue to a duet, much less to a duel. And the effect of mentioning "another voice," which one sometimes hears without reading it, will often be to put one on one's guard. It signals that each of the two voices yields to still others. I repeat, they are indeterminate in number: the voice of the signatory of the texts is the figure of only one among others, and it is not certain whether this figure is masculine; nor whether the other is a woman.

But the words "another voice" recall not only the complex multiplicity of people, they "call," they "ask for" another voice: "another voice, again, yet another voice." It is a desire, an order, a prayer or a promise, as you wish: "another voice, may it come soon now, again, another voice . . ." An order or a promise, the desire of a prayer, I don't know, not yet.

"Moving off of itself, forming itself wholly therein, almost without remainder, writing denies and recognizes its debt in a single dash. The utmost disintegration of the signature, far from the center, indeed from the secrets that are shared there, divided up so as to scatter even their ashes.

"Though the letter gains strength solely from this indirection, and granted that it can always not arrive at the other side, I will not use this as a pretext to absent myself from the punctuality of a dedication: R. Gasché, J. J. Goux, J. C. Lebensztejn, J. H. Miller, others, cinders there are [il y a là cendre], will recognize, perhaps, what their reading has contributed here. December 1971."

*"S'écartant d'elle-même, s'y formant toute, presque sans reste, l'écriture d'un seul trait renie et reconnaît la dette. Effondrement extrême de la signature, loin du centre, voire des secrets qui s'y partagent pour disperser jusqu'à leur cendre.*

*"Que la lettre soit forte en cette seule indirection, et de toujours pouvoir manquer l'arrive, je n'en prendrai pas prétexte pour m'absenter à la pontualité d'une dédicace: R. Gasché, J.-J. – Et près de la fin, au bas de la dernière page, c'est comme si tu signais de ces mots: "Il y a là cendre." Je lisais, relisais, c'était si simple et pourtant je comprenais que je n'y étais pas, la phrase se retirait sans m'attendre vers son secret.

– D'autant plus que ce mot, là, vous ne le donniez plus à entendre. A l'écouter seulement, les yeux fermés, j'aimais me rassurer en murmurant la cendre, confondant ce là, oui, avec le singulier féminin d'un article définissant. Il fallait déchiffrer sans perdre l'équilibre, entre l'œil et l'oreille, je ne suis pas sûre d'avoir pu m'y arrêter.

– J'avais d'abord imaginé pour ma part que cendre était là, non pas ici mais là comme l'histoire à raconter: la cendre, ce vieux mot gris, ce thème poussiéreux de l'humanité, l'image immémoriale s'était d'elle-même décomposée, métaphore ou métonymie de soi, tel est le destin de toute cendre, séparée, consumée comme une cendre de cendre. Qui oserait encore se risquer au poème de la cendre? Le mot de cendre, on rêverait qu'il fût: lui-même une cendre en ce sens, là, là-bas, éloigné dans le passé, mémoire perdue pour ce qui n'est plus d'ici. Et par là, sa phrase aurait voulu dire, sans rien garder: la cendre n'est plus ici. Y fut-elle jamais?

– And near the end, at the bottom of the last page, it was as though you had signed with these words: "Cinders there are." I read, reread them; it was so simple, and yet I knew that I was not there; without waiting for me the phrase withdrew into its secret.

– All the more because this word, *là*, "there," you would no longer let it be heard. Listening only to it, with eyes closed, I liked putting my mind at rest by whispering "the cinder," confusing this *là*, "there," yes, with *la*, the singular feminine definite article. It was necessary to decipher without losing equilibrium between the eye and the ear; I am not sure that I was ever able to achieve it.

– As for me, I had at first imagined that cinders were there, not here but there, as a story to be told: cinder, this old gray word, this dusty theme of humanity, the immemorial image had decomposed from within, a metaphor or metonymy of itself, such is the destiny of every cinder, separated, consumed like a cinder of cinders. Who would still dare run the risk of a poem of the cinder? One might dream that the word "cinder" was itself a cinder in that sense, "there," "over there," in the distant past, a lost memory of what is no longer here. And thereby [*par là*] its phrase would have meant, without holding anything back: the cinder is no longer here. Was [*fut*] it ever?



– Il y a là cendre, quand cela fut, il y a près de dix ans, la phrase éloignait d'elle-même. En elle, elle portait le lointain. Malgré sa place et l'apparence elle ne se laissait pas signer, elle n'appartenait plus, un peu comme si, ne signifiant rien qui fût intelligible, elle venait de très loin à la rencontre de son présumé signataire qui ne la lisait même pas, la recevait à peine, la rêvait plutôt comme une légende, une fumée de tabac: ces mots qui sortent de votre bouche et vont se perdre sans reconnaissance.

La cendre n'est pas ici mais il y a là Cendre.

– Qui est Cendre? Où est-elle? Où court-elle à cette heure? Si l'homophonie retient le nom singulier dans le nom commun, ce fut bien là, une personne disparue mais une chose qui en garde et à la fois perd la trace, la

– Cinders there are; when that happened [*fut*] nearly ten years ago the phrase withdrew from itself. The phrase carried distance within itself, within herself. Despite its venue and despite all appearances, it did not permit itself, did not permit herself, to sign; it no longer belonged; somewhat as if, signifying nothing that was [*fût*] intelligible, the phrase came from very far away to meet its supposed signatory, who did not even read it, who scarcely received it, dreamed it rather, like a legend or a saying, a whiff of tobacco smoke: these words that leave your mouth only to be lost in unrecognizability.

– Just suppose, this is what I would have liked to ask (but whom? This morning, for the first time, ten years later, I became aware to the point of being able to admit to myself that something about this reading is imprinted in me, in a place sheltered but ready for silent ecstasy: the article missing before such cinders, in a word, the resemblance sketched by this homophonic *là*, “there,” made a feminine phantom tremble deep within the word, in the smoke, the proper name deep within the common noun. The cinder is not here, but Cinder there is.

– Who is Cinder? Where is she? Where did she run off to at this hour? If the homophony withholds the singular name within the common noun, it was surely “there,” *là*; someone vanished but something preserved her trace and at the same time lost it, the

– Suppose, aurais je demandé, que cette légende seulement signale, et pour ne rien dire d'autre que soi: je suis un signal de cendre, je rappelle quelque chose ou quel-

cinder. There the cinder is: that which preserves in order no longer to preserve, dooming the remnant to dissolution. And it is no longer the one who has disappeared who leaves cinders “there”; it is only her still unreadable name. And nothing prevents us from thinking that this may also be the nickname of the so-called signatory. Cinders there are, the phrase thus says what it does, what it is. It immediately incinerates itself, in front of your eyes: an impossible mission (but I do not like this verb, “to incinerate”; I find in it no affinity with the vulnerable tenderness, with the patience of a cinder. The verb is active, acute, incisive).

– No, the phrase does not say what it is, but what it was [*fut*], and since this vocable was [*fut*] just used by you so many times, do not forget that it remains in memory of the departed [*feu*], of the word *feu* in the idiom, “the late so and so,” the departed, the bereaved. Cinder of all our lost etymologies, *fatum, fuit, functus, defunctus*.

– The sentence says what it will have been, from the moment it gives itself up to itself, giving itself as its own proper name, the consumed (and consummate) art of the secret: of knowing how to keep itself from showing.

– Just suppose, I would have asked, that this saying only gives a signal and only in order to say nothing other than itself: I am a cinder signal, I recall something or someone of whom I will say nothing but

this rough sketch obviously in order to say that nothing will have had to annul what is said in its saying, to give it to the fire, to destroy it in the flame, and not otherwise. No cinder without fire [*feu*].

That is what is owed to the fire, and yet, if possible, without the shadow of a sacrifice, at noon, without debt, without the Phoenix, thus the unique phrase comes to set into place, in the place of no emplacement, the place solely of an incineration. The sentence avows only the ongoing incineration, of which it remains the almost silent monument: this can be “there,” *là* –

– But why would you have given it to the fire? To preserve the hiddenness of mourning's ashen grayness, or to undo it by letting it be seen, the half-mourning that persists only as long as the time of a cinder? Why cinders “there”? The place of burning, but of what, of whom? As long as one does not know, and you will never know, the sentence says what it said earlier, the incinerated is no longer nothing, nothing but the cinder, the innermost cinder furnace, a remnant that must no longer remain, this place of nothing that may be, a pure place was marked out.

– Pure is the word. It calls for fire. Cinders there are, this is what takes place in letting a place occur, so that it will be understood: Nothing will have taken place but the place. Cinders there are: Place there is (*il y a lieu*).



– Où? Ici? Là? Où sont des mots sur une page?

– Il y a prescription. L'idiome "il y a lieu," jamais vous ne le traduirez, non plus qu'un nom propre caché or le voici qui déporte tout: vers la reconnaissance, la dette, le devoir, la prescription. Il y a lieu de ceci, un nom propre, il y a lieu de faire ceci ou cela, de donner, de rendre, de célébrer, d'aimer. – Where? Here? There? Where are the words on a page?

– There are prescribed limits. The idiom *il y a lieu*, you will never translate it, no more than you will a hidden proper name, for this is what carries everything away: toward the recognition, the debt, the obligation, the prescribed limit. There is a place for this, a proper name, place there is for doing this or that, for giving, rendering, celebrating, loving. And because of this, the locality of the legend ("cinders there are") surrounds it with friendship, bestowing grace and dissemination at the same time. Cinders there are, that was *[fut]* finally like the fragile, singed, and crumbling title of the book, *Dissemination*. Discreetly pushed to the side, dissemination thus expresses in five words [*il y a là cendre*] what is destined, by the fire, to dispersion without return, the pyrification of what does not remain and returns to no one.

– If a place is itself surrounded by fire (falls finally to ash, into a cinder tomb), it no longer is. Cinder remains, cinder there is, which we can translate: the cinder is not, is not what is. It remains *from* what is not, in order to recall at the delicate, charred bottom of itself only non-being or non-presence. Being without presence has not been and will no longer be there where there is cinder and where this other memory would speak. There, where cinder means the difference between what remains and what is, will she ever reach it, there?

– Perhaps he finds it unseemly to have to comment, even to read and to cite this phrase: he is, in effect, "really incensed" at having, in a word, "to incense" it. Regardless what he may say, "cinder there is" remains his. And everything we will say and advance here about it, concerning the legal signature that he pretends to undermine, he will reinstate it, he will take it back again, will give it to the hearth of its own burning – or of its own family. There are cinders only insofar as there is the hearth, the fireplace, some fire or place. Cinder as the house of being . . .

– Your precaution is naive. He will answer however he chooses. While the phrase appears in a book bearing his signature, it does not belong to him. He admits having already read it before writing it, before writing her. She, this cinder, was given or lent to him by so many others, through so much forgetting, and besides, no one here flatters this secret with a commentary. We literally unveil nothing of her, nothing that in the final account does not leave her intact, virginal (that's the only thing he loves), undecipherable, impassively tacit, in a word, sheltered from the cinder that there is and that she is. For abandoned to its solitude, witness to whomever or whatever, the sentence does not even say the cinder. This thing of which one knows nothing, knows neither what past is still carried in these gray dusty words, nor what substance came to consume itself there before extinguishing itself there (do you know

At present, here and now, there is something material – visible but scarcely readable – that, referring only to itself, no longer makes a trace, unless it traces only by losing the trace it scarcely leaves

– that it just barely remains

– but that is just what he calls the trace, this effacement. I have the impression now that the best paradigm for the trace, for him, is not, as some have believed, and he as well, perhaps, the trail of the hunt, the fraying, the furrow in the sand, the wake in the sea, the love of the step for its imprint, but the cinder (what remains without remaining from the holocaust, from the all-burning, from the incineration the incense)

– That it remains for very few people, and, however slightly one touches it, it falls, it does not fall into cinders, it gets lost down to the cinder of its cinders. In writing this way, he burns one more time, he burns what he still adores although he has already burned it, he is intent on it

"The all-burning – that has taken place once and nonetheless repeats itself ad infinitum – diverges so well from all essential generality that it resembles the pure difference of an absolute accident. Play and pure difference, those are the secret of an imperceptible all-burning, the torrent of fire that sets itself ablaze. Letting itself get carried away, pure difference is different from itself, therefore indifferent. The pure play of difference is nothing, does not even relate to its own conflagration. The light envelops itself in darkness even before becoming subject."

"How, from this consuming destruction without limit, can there remain something that primes the dialectical process and opens history?"

"How would the purest of the pure, the worst of the worst, the panic blaze of the all-burning, put forth some monument, even were it a crematory? Some stable, geometric, solid form, for example, a pyramis that guards the trace of death? Pyramis is also a cake of honey and flour. It was offered as a reward for a sleepless night to the one who thus remained awake."

"If the all-burning destroys up to its letter and its body, how can it guard the trace of itself and breach/broach a history where it preserves itself in losing itself?"

Here is experienced the implacable force of sense, of mediation, of the hard-working negative. In order to be what it is, purity of play, of difference, of consuming destruction, the all-burning must pass into its contrary, guard itself, guard its own monument of loss, appear as what it is in its very disappearance. As soon as it appears, as soon as the fire shows itself, it remains, it keeps hold of itself, it loses itself as fire. Pure difference, different from (it)self, ceases to be what it is in order to remain what it is. That is the origin of history, the beginning of the going down [déclin], the set-

Then in place of burning all, one begins to love flowers. The religion of flowers follows the religion of the sun.

The erection of the pyramid guards life – the dead – in order to give rise [donner lieu] to the for-(it)self of adoration. This has the signification of a sacrifice, of an offer by which the all-burning annuls itself, opens the annulus, contracts the annulus into the anniversary of the solar revolution in sacrificing itself as the all-burning, therefore in guarding itself."

"The chance of substance, of the remnance [restance] determined as subsistence."

"The difference and the play of the pure light, the panic and pyromaniac dissemination, the all-burning offers itself as a holocaust to the for-(it)self, gibt sich dem Fürsichsein zum Opfer.

— ✨ ✨ <It sacrifices itself, but only to remain> to insure its guarding, to bind itself to itself strictly, to become itself, for-(it)self, (close)-by-(it)self. In order to sacrifice itself, it burns itself."

"A panic, limitless inversion: the word holocaust that happens to translate Opfer is more appropriate to the text than the word of Hegel himself. In this sacrifice, all (holos) is burned (caustos), and the fire can go out only stoked."

"What puts itself in play in this holocaust of play itself?"

This perhaps: the gift, the sacrifice, the putting into play or the setting on fire of everything, the holocaust contains the seeds of ontology. Without the holocaust the dialectical movement and the history of Being could not open themselves, engage themselves in the annulus of their anniversary, could not annul themselves in producing the solar course from Orient to Occident. Before, if one could count here with time, before everything, before every determinable being [étant], there is, there was, there will

and I sense it, I mean the  
odor of the body, perhaps his. All these cinders, he

– One says “warm cinders,” “cold cinders,” depend-

has for consistency only its syntax and for body only  
its vocabulary? Does this make the words warm or  
cold? Neither warm nor cold. And the gray form of  
these letters? Between black and white, the color of  
writing resembles the only “literality” of the cinder  
that still inheres in a language. In a cinder of words,  
in the cinder of a name, the cinder itself, the literal –  
that which he loves – has disappeared. The name  
“cinder” is still a cinder of the cinder itself.

– That is why the cinder in a sentence here no longer  
is, but cinder there is.

tence, perhaps they still know it, perhaps he knows at least something about it. But even tonight he may still discover what is unknown or unconscious in this saying that he sometimes says he has read and sometimes, I recall his expression, forged. He had pronounced it with an English accent, my "counterfeiter's forgery." He will of course die someday; and for however brief a time, the little phrase has some chance of surviving him, more a cinder than ever, there, and less than ever without anyone to say "I."

– But the counterfeiter can lie, he's lying, I am almost sure of it, from experience. There is doubtless no real secret at the bottom of this sentence, no determined proper name. Once he confided to me, but I still do not believe that the first letter of almost every word, I.L.Y.A.L.C. [*il y a là cendre*], was the first letter of another word, all of it expressing, but in a foreign language, an entirely different statement, which would have played the role of a coded proper name, in truth his ciphered signature. I believed none of it, he had just invented the hoax, he can always lie or not even be certain of what he claims to know. It is precisely at this point that the cinder is there. If he were sure of the truth of his knowledge, why would he have this desire to write and above all to publish a phrase that makes itself indeterminate in

this way? Why set adrift and “clandestine” in this way such a readable proposition? His proposition, that cinders there were, finally consists, in its extreme fragility and in the little time at its disposal (its life will have been so short), of this non-knowledge toward which writing and recognition, always a pair, are precipitated. One and the other, both of them, are compelled into the same crypt.

– Through the patient, tormenting, ironic return of the exegesis that leads to nothing and which the unsophisticated would find unseemly, would we be molding the urn of a language for this cinder sentence, which he, he, has abandoned to its chance and to fate, a self-destructive virtue firing on its own right into the heart.

– But the urn of language is so fragile. It crumbles and immediately you blow into the dust of words which are the cinder itself. And if you entrust it to paper, it is all the better to inflame you with, my dear, you will eat yourself up immediately. No, this is not the tomb he would have dreamed of in order that there may be a place [*y ait lieu*], as they say, for the work of mourning to take its time. In this sentence I see the tomb of a tomb, the monument of an impossible tomb – forbidden, like the memory of a

cenotaph, deprived of the patience of mourning, denied also the slow decomposition that shelters, locates, lodges, hospitalizes itself in you while you eat the pieces (he did not want to eat the piece but was forced to). An incineration celebrates perhaps the nothing of the all, its destruction without return but mad with its desire and with its cunning (all the better to preserve everything, my dear), the desperately disseminal affirmation but also just the opposite, the categorical "no" to the laborious work of mourning, a "no" of fire. Can one ever accept working for His Highness Mourning?

– How can one not accept it? That is what mourning is, the history of its refusal, the narrative of your revolution, your rebellion, my angel, when it enters into history and at midnight you marry a prince. As for the urn of the spoken tongue, even were [*fût*] it a tongue of fire, do not think that it breaks up easily. And do not lie, you well know how solid a sentence is. By its very disappearance it resists so very many eclipses, it always has a chance of returning, it "incenses" itself to infinity. This is so much more certain finally than placing the archive in a reinforced beam destined for our extra-terrestrial cousins. The sentence is adorned with all of its dead. And all the better to eat yourself with, say the grandmother and the wolf for whom you work; it is still to the benefit of mourning.

*“... And to finish that Second Letter: ‘... Consider these facts and take care lest you sometime come to repent of having now unwisely published your views. It is a very great safeguard to learn by heart instead of writing... to me graphein all’ekmanthanien... It is impossible for what is written not to be disclosed. That is the reason why I have never written anything about these things... oud’estin sungramma Platonos ouden oud’estai, and why there is not and will not be any written work of Plato’s own. What are now called his... Sokratous estin kalou kai neou gegonotos... are the work of a Socrates embellished and modernized. Farewell and believe. Read this letter now at once many times and burn it...’*

*– I hope this one won’t get lost. Quick, a duplicate... graphite... carbon... reread this letter... burn it. Cinders there are [il y a là cendre]. And now, to distinguish, between two repetitions...*

– Si c'était moi, j'aurais préféré n'avoir jamais écrit cela, je l'aurais aussitôt brûlé.

– Now, through this precise return of the cinders, and for a long time I have observed you when you write, what returns from the breathless race makes its way on a long cinder track. No matter how much you resist it, you have mass and volume only when covered with cinders, as one covers one's head with ashes in a sign of mourning.

– There is rebellion against the Phoenix and also the affirmation of the fire without place or mourning.

– The sentence remains visible for me and even before rereading it, its image in my memory is imprinted in the plural: cinders there are. A faulty version to be buried, as do the Jews when a manuscript has wounded the name of God. The “s,” silent so that it cannot be heard and to change nothing in the hearing, my memory played with that; and with the singular homophone [*cendre*] it played a game more discriminating, more reassuring, no doubt. But this “there” from now on signified that the innumerable lurks beneath the cinder. Incubation of the fire lurking beneath the dust.

– The fire: what one cannot extinguish in this trace among others that is a cinder. Memory or oblivion, as you wish, but of the fire, trait that still relates to the burning. No doubt the fire has withdrawn, the conflagration has been subdued, but if cinder there is, it is because the fire remains in retreat. By its retreat it still feigns having abandoned the terrain. It still camouflages, it disguises itself, beneath the multiplicity, the dust, the makeup powder, the insistent pharmakon of a plural body that no longer belongs to itself – not to remain nearby itself, not to belong to itself, there is the essence of the cinder, its cinder itself.

– Above the sacred place, incense again, but no monument, no Phoenix, no erection that stands – or falls –, the cinder without ascension, the cinders love me, they change sex, they re-cinder themselves, they androgynocide themselves.

– She plays with words as one plays with fire, I would denounce her as a pyromaniac who wants to make us forget that in Sicily churches are built with the stone of lava. Pyrotechnical writing feigns abandoning everything to what goes up in smoke, leaving there only cinder that does not remain. – With these citations, these references, you authorize the cinder, you will construct a new university, perhaps. But listen to Virginia Woolf in *Three Guineas*: “No guinea of earned money [money earned by the women] should go to rebuilding the college on the old plan; just as certainly none could be spent upon building a college upon a new plan; therefore the guinea should be earmarked ‘Rags. Petrol. Matches.’ And this note should be attached to it. ‘Take this guinea and with it burn the college to the ground. Set fire to the old hypocrisies. Let the light of the burning building scare the nightingales and incarnadine the willows. And let the daughters of educated men dance round the fire and heap armful upon armful of dead leaves upon the flames. And let their mothers lean from the upper windows and cry, Let it blaze! Let it blaze! For we have done with this “education”!’ ”

– One must still know how to “let it blaze.” One must be good at it. There is also Nietzsche’s paradox – which makes him something else perhaps than a thinker of the totality of entities [*l’étant*] – when he no longer normalizes the relation of the cinder to the whole by treating it as part of the whole, or by

Or elsewhere (*Gay Science*): "Let us guard against saying that death is opposed to life. The living being is only a species of what is dead, and a very rare species."

– In the first legend, which comes after the second, after her, the movement of the dedication (recognition of debt and non-restitution) says at least, shows by barely saying that the cinder comes in place of the gift. Gift there would have been, even if it is not said, as it should be so that it may take place, from whatever or whomever. Recognition and denial of a debt, of a "single divided trait," "far from the center." And from a mere letter, indebted to a dental *d/t* flung from the tongue ("Though the letter gains strength solely from this indirection"), a center crumbles and melts, it is dispersed in a throw of the die: cinder.

– Mute, the dedication feigns restitution. But it only knows how to render or give nothing but fiery dust; it says nothing, it allows nothing of itself to appear,

– It is obviously a figure, although no face lets itself be seen. The name "cinder" figures, and because there is no cinder here, not here (nothing to touch, no color, no body, only words), but above all because these words, which through the name are supposed to name not the word but the thing, they are what names one thing in the place of another, metonymy when the cinder is separated, one thing while figuring another from which nothing figurable remains.

– A word, unfit even to name the cinder in the place of the memory of something else, and no longer referring back to it, how can a word ever present itself? The word, like the cinder, similar to her, comparable to the point of hallucination. Cinder, the word, is never found here, but there.

– For that it is necessary that you take the word into your mouth, when you breathe, whence the cinder comes to the vocable, which disappears from sight,

But what is a word for consuming itself all the way to its support (the tape-recorded voice or strip of paper, self-destruction of the impossible emission once the order is given), to the point of assimilating it without apparent remainder? And you can also receive semen through the ear.

– What a difference between cinder and smoke: the latter apparently gets lost, and better still, without perceptible remainder, for it rises, it takes to the air, it is spirited away, sublimated. The cinder – falls, tires, lets go, more material since it fritters away its word; it is very divisible.

– I understand that the cinder is nothing that can be in the world, nothing that remains as an entity [*étant*]. It is the being [*l'être*], rather, that there is – this is a name of the being that there is there but which, giving itself (*es gibt ashes*), is nothing, remains beyond everything that is (*konis epekeina tes ousias*), remains unpronounceable in order to make saying possible although it is nothing.

If you aren’t there, my body is to be pulled out of the lake [lac] and burned, my ashes are to be sent to you, the urn well protected (‘fragile’) but not registered, in order to tempt fate. This would be an envoi of/from me [un envoi de moi] which no longer would come from me (or an envoi sent by me, who would have ordered it, but no longer an envoi of me, as you like). And then you would enjoy mixing my cinders

the *ceniza* of Francisco de Quevedo, his sonnets "To Vesuvius," and "I am cinder that darkens in the flame / nothing that remains to consume the fire / that in amorous conflagration is dispersed," that "will be cinder, but will remain sentient / will be dust, but amorous dust."

– I hear well, I hear it, for I still have an ear for the flame even if a cinder is silent, as if he burned paper at a distance, with a lens, a concentration of light as a result of seeing in order not to see, writing in the passion of non-knowledge rather than of the secret. I would say, for the protection and illustration of its own sentence, "I" the cinder would say that his writing is not interested in knowledge. The raw cinder, that is more to his taste; and the initial consonant matters very little; every word seems to finish with ( )inder, whether it's a common or proper noun, or even a verb, even a noun that we make into a verb – "tinder," "to tinder" – for the cinder makes every word "tinder." What does he do with DER? I wonder: (scin-, [pre]scin-, [re]scin-, DER). I leave it to you to find examples.

– And with this lack that is *la cendre*, these *lac(k)s*, this *lac(k)(s)* – when he gets all entangled with telepathy, there [*là*] also *LA Cinder* is there.

– No, you treat his phrase like the accumulation of surplus-value, as if he speculated on some cinder

*mes cendres à ce que tu manges (café le matin, pain brioché, thé à 5 heures, etc.). Passé une certaine dose, tu commencerais à t'engourdir, à tomber amoureuse de toi, je te regarderais t'avancer doucement vers la mort, tu t'approcherais de moi en toi avec une sérénité dont nous n'avons pas idée, la réconciliation absolue. Et tu donnerais des ordres . . . En t'attendant je vais dormir, tu es toujours là, mon doux amour."*

with what you eat (morning coffee, brioche, tea at 5 o'clock, etc.). After a certain dose, you would start to go numb, to fall in love with yourself, I would watch you slowly advance toward death, you would approach me within you with a serenity that we have no idea of, absolute reconciliation. And you would give orders . . . While waiting for you I'm going to sleep, you're always there, my sweet love."

77. We reprint the phrase “pas un corpus” from the 1982 text of *Feu la cendre* rather than “par un corpus” from the 1987 version. Both readings are, however, revealing in their own way. The gift on which one takes a chance is and is not a body; it is, rather, what remains of a corpse whose form is no longer decipherable. Was it ever?

37. *Fors la cendre*, “nothing but the cinder,” but also *for la cendre*, as in *le for intérieur*, one’s innermost sense, thus “the innermost cinder”; *le four*, the furnace or oven, is not far off.

37. *Un lieu pur se chiffât-il*. Derrida echoes the “taking place” of “place” (RIEN N’AURA EU LIEU QUE LE LIEU) *dans ces parages du vague*, “in these vague regions,” from Mallarmé’s “Un Coup de dés,” where it is a question of hallucination, agony, and the unconcealment of the concealment of the origin of number (LE NOMBRE . . . *clos quand apparû*), where it is a question of “tallying up the whole” (SE CHIFFRAT-IL / *évidence de la somme*).

37. *Pur est le mot*. *Pur* = *Pyr*, Greek for “fire.” Thus, *pyrification*.

39. *Tombe en tant que nom*. *Tombe*, as a noun, is “tomb”; as a verb, it means “falls.”

41. *Encenser*, to praise or extol, as well as to burn incense, also sounds out *insensé*, insane or maddened; the English “incense” or “incensed” contains all these meanings.

53. “Clandestining” is the inevitable effect that the cinder *envoi* has on the sending of any letter.

55. “Rien du tout,” “nothing at all,” or “the nothing of the all.”

57. Although the saying “il y a là cendre” appears in “Plato’s Pharmacy” prior to its appearance in the dedicatory *envoi* at the very end of *Dissemination*, this allusion was in fact written after the one in the concluding acknowledgments. In distinguishing between the repetitions at work here, Derrida is reminded of Plato “mutter[ing] . . . [i]n the enclosed space of the pharmacy” as he begins to analyze the *pharmakon* [*Dissemination* 169]. In “Plato’s Pharmacy” and more recently in “Chôra” [in *Poikilia: Études Offertes à Jean-Pierre Vernant* (Paris: Éditions de L’École des hautes études en sciences sociales, 1987); 265–96], Derrida presents *chôra* as

Plato's most challenging version of this "enclosed space," the "place" rather, the "mother and receptacle of this generated world" (*Timaeus* 51a), "there" between the unchanging Forms (*eidos*) on the outside and the mutable copies (*eikon*) on the inside.

59. "Cinders" makes the silent "s" in "cendres" audible. Here we might cite from T. E. Hulme's "Cinders," the final section of his *Speculations* (1924): "That the world is finite [. . .] and that it is yet an infinitude of cinders." Levinas has written of the Jewish custom of burying a faulty manuscript.

67. Derrida's caesura is formed from four of the fourteen lines of Mallarmé's sonnet, "Toute l'âme résumée," in *Hommages et Tombeaux*, where Mallarmé compares the expiration of the soul to the separation of the ash from the burning cinder (*la cendre se sépare / De son clair baiser de feu*) in a well-smoked cigar (*quelque cigare / Brûlant savamment*). Here lies perhaps a trace of the promised "history of tobacco." Incidentally, Baudelaire's prose poem, "Counterfeit Money," concerns a "singularly minute repartitioning" of the notion of the gift that occurs as two friends exit a tobacconist's shop. Derrida analyzes Mauss and Baudelaire in detail in *Donner le temps (Given Time)* (forthcoming).

69. The first Nietzsche citation is from notes made in 1881 during the composition of *The Gay Science* (Friedrich Nietzsche, *Idyllen aus Messina / Die fröhliche Wissenschaft / Nachgelassene Fragmente Frühjahr 1881 bis Sommer 1882*, in *Kritische Gesamtausgabe: Werke*, pt. 5, vol. 2, eds. Giorgio Colli and Mazzino Montinari [Berlin: Walter de Gruyter, 1973], 370–71).

69. The mortal throw of the die that is the exhalation of a vocable, at once delivers the gift and the debt, dissemination and grace, the necessity and impossibility of return; thus cinders fall to ash, "dé:cendre." The "thrownness" of Dasein is very much the work of the tongue.

71. "Sable brûlant ou pas," burning sand or not, also suggests the heat of the non-negative "step," the *pas*, the "stop" or obstruction to which we can be so anesthetized that we no longer feel the non-presence burning within language.

73. The "impossible emission" recalls, of course, the TV series *Mission Impossible*.

73. *Konis epekeina tes ousias* (cinders beyond being or presence) rewrites Plato's *agathon epekeina tes ousias* (The good beyond being).

73. "Griller une distance" means "to overrun a distance," here in the sense of being unable to stop because the very notion of a distance between languages has been annulled; the burning and the grilling begin as soon as one steps beyond a language and toward language itself.

75. "For the defense and illustration of the French language" is an expression of L'Académie Française.

75. "Tendre," like the English "tender" or "to tender," means something delicate or fragile that is extended or tendered within language; it rhymes with "cendre." Tinder and the neologism, "to tinder," make these motifs explicit and rhyme with "cinder."

75. *Sans* = without, *sens* = sense, *sang* = blood, and *cent* = one hundred, are all homonyms of *cen-dre*. "Scin-der" may suggest "scintilla," the slightest trace or spark, and the Latin "scindere," to cut or separate, and leads readily to "prescinding" (separation) and "rescinding" (annulment).
